Terms and Conditions for Rites for Girls training and girls' groups

Cancellation and Refund Policy

Girls Journeying Together groups

Parents sign their child up for a programme of 12 sessions over one year. Payment can be made in full before the course or in 12 monthly payments. Payment is due whether the child attends each session or not.

Girls Net groups

Parents sign their child up for a programme of 6 sessions. Payment is made in full before the course or as agreed with your Girls' Net Mentor. Payment is due whether the child attends each session or not.

Rites for Girls Workshops and Talks

A 25% cancellation fee will be retained for cancellations made in writing prior to 14 days of the workshop date. Fees are non-refundable after that date. We reserve the right to cancel, postpone, or change venue of a training, talk, or workshop in the highly unlikely event of low enrolment, weather conditions, or other unforeseen circumstances. Please note that we are not responsible for refunding travel expenses or other costs incurred due to cancellations by either party.

Transfer Policy

A £25 transfer fee will be charged to registrants who wish to transfer their registration or receive a credit to apply toward any future workshop or training, space permitting. Registrants will be charged or credited for any difference in tuition fees.

Telephone consultations

Sessions last one hour. If you are late to a session, we will still need to finish at the agreed time. Payment must be made in full by bank transfer at last 24 hours **before** the session. Please give as much notice as possible if you need to change day/time or

cancel. No refund will be made if you cancel a session within less than 24 hours of the agreed start time.

Rites for Girls Facilitator and Mentor Training

The registration deposit will be retained for cancellations made in writing prior to 14 days of the workshop date. Fees and deposit are non-refundable after that date. We reserve the right to cancel, postpone, or change venue of a training in the highly unlikely event of low enrolment, weather conditions, or other unforeseen circumstances. Please note that we are not responsible for refunding travel expenses or other costs incurred due to cancellations by either party.
